The Feeder Calf Project animal will be either a December or January born bull calf of a recognized dairy breed as described by the American Dairy Cattle Association Standards.

I understand that the calf or calves must be ear tagged no later than Feb 7<sup>th</sup> 2016. A photo of the calf must be submitted by Feb 15<sup>th</sup>, 2016 to the BERLIN FAIR MARKET LIVESTOCK COMMITTEE EMAIL ADDRESS.

Each 4-H club is responsible for ear tagging the calves in their club and it will be the responsibility of the 4-H member to take a picture of the calf with the ear tag visible, they will have 7 days to send the picture.

The recommendations of the Coopersville Vet Clinic for the vaccination program for the 2016 fair will be as follows: **Bovi Shield One Shot and Vision 7 at 3 months of age followed with a booster at 4 months of age.**

I have read and agree to abide by the current 4-H Market Livestock Guidelines and the Ottawa County 4-H Code of Conduct policy. I also understand that there is a percentage that is deducted from the 4-H members' market livestock sale checks, it is a 4% fee, the money that is deducted from sale check is used to pay for the yearly expenses that are from the 4-H Livestock Sale which includes but not limited to; 2-\$500 College Scholarships, the buyers dinner at the fair, livestock pictures, portion of the judges fees, ear tags, calibration and certification of the livestock scales, trucking of livestock to slaughter houses or sale barns, postage to send letters to buyers, and office supplies.

I understand that the MSUE participation fee of \$10 must be paid before the calves are ear tagged.

All feeder calves MUST be vaccinated, castrated, and dehorned before the start of the fair.
